

Site Analysis

A site analysis was undertaken for both the Northern and Western Growth Investigation Areas to determine the characteristics and extent of the growth areas. This analysis identifies the considerations, opportunities and constraints and is also informed by submissions

Criterion	Explanation
Servicing and Infrastructure Considerations	The existing and future ability to provide/upgrade and fund trunk services that can support urban development (drainage, sewer, water, electricity, etc). Liaison with key servicing authorities has occurred and is ongoing to ensure authorities can actively plan for the City's growth.
Existing Planning Zones	Provides insight into existing land uses planning and activity in and around the growth areas
Existing Planning Overlays	Provides insight into key environmental and built form constraints in and around growth areas
Landforms and Natural Constraints	Low points, high points, natural features such as creeks, hilltops and stands of vegetation that may inhibit development or should be considered as part of future planning
Heritage and Aboriginal Cultural Heritage	High level assessment of known historical and cultural significance areas that guide understanding
Movement Network	High level analysis of constraints and opportunities provided by existing road and other access opportunities e.g. public transport which can unlock development or provide for clear boundaries for the growth areas.
Land Uses	Desktop review of existing land uses, facilities, services, community infrastructure, etc in and around the growth areas that future planning will have regard to.

Servicing and infrastructure Considerations

The Northern Growth Area can be serviced by trunk services and is in close proximity to the Wastewater Treatment Plant. The area falls within a single drainage catchment, with Burrumbeet Creek its focus. Future planning will be required to determine how infrastructure is to be upgraded and staged to accommodate development. Existing Council recreation and community infrastructure in and around Miners Rest can be upgraded as a result of new growth.

The Western Growth can be serviced with investment of trunk service extensions. Future planning will be required to determine how infrastructure is to be upgraded and staged to accommodate development. A planned temporary sewer pump station will provide some immediate capacity for development around Cuthberts Road, however ultimate planning and investment in sewer is

required holistically as part of preparation of a PSP. Drainage is complicated falling within three catchment areas that will require more detailed assessment to understand drainage infrastructure requirements to service development. The scale of the growth area means future planning will need to investigate existing and new recreation and community infrastructure to support growth.

Existing Zones

The Northern Growth Area is primarily zoned Farming Zone. The Special Use Zone identifies the Dowling Forest Equine Precinct to the north and the broader equine precinct and hobby farms is zoned the Farming Zone. The Rural Living Zone characterises development around Mt Rowan and the Public Use Zone identifies the Central Highlands Water Treatment Plant. The area sits adjacent to existing industrial areas including Ballarat West Employment Zone and the Old Midland Highway.

The Western Growth Area is typically zoned Farming Zone. Historical subdivisions particularly south of Glenelg Highway and in proximity to Finches Road has seen the area develop as rural living rather than for farming purposes. Beyond the Skipton Rail Trail, land is zoned Comprehensive Development Zone (North-West Growth Investigation Area) and within developer control.

Existing Overlays

The Northern Growth Area is defined by overlays which protect the Burrumbeet Creek environs and existing flooding extents. Bushfire Management Overlays extend around the Wastewater Treatment Plant facility into the growth area. The Significant Landscape Overlay protects Mt Rowan however does not fully capture its landscape extent. The Design and Development Overlay associated with the Ballarat Airfield encroaches slightly into the western area, from Miners Rest. An overlay protects odour emitted from the Wastewater Treatment Plant and the Special Control Overlay identifies a potential school site within the growth area.

The Western Growth Area a Bushfire Management Overlay over some parcels. Environmental Significant Overlays extend through fragmented areas protecting key vegetation and environs. A Public Acquisition Overlay along Dyson Road reserves the potential for the Western Ballarat Ring Road and will link the existing Ballarat West Growth area to the new Ballarat West Growth area. A Heritage Overlay identifies a cottage and associated buildings on Glenelg Highway.

Landforms and Natural Considerations

The Northern Growth Area has attractive, natural qualities thanks to the presence of Mt Rowan and the Burrumbeet Creek environs. Land is undulating in areas and falls at different gradients to the Creek. Windrows and stands of trees along the creek and flat areas coincide with the land subject to inundation and flooding. The Growth Area has opportunity to create Ballarat's northern

gateway experience into town which draws upon and protects its natural landscape qualities, with long views to the surrounding hills and forests.

The Western Growth area is typically flat with similar landscape qualities to the existing Ballarat West Precinct Structure Plan area. Natural drainage lines have created some depressions and areas of flooding through the area with low level of tree coverage thanks to the farming history of the area. Further north, Remembrance Drive creates Ballarat's western entry, creating a historic connection into the City thanks to the historically significant Avenue of Honour.

Movement Network

The Northern Growth Area is accessible via linkages across the Western Highway such as the Midland Highway and Gillies Street. There is limited east-west connectivity to Miners Rest due to Burrumbeet Creek, however there are opportunities to investigate improved connections. Gillies Street forms the central north-south spine. Roads are typically of a rural standard however have potential to be planned and upgraded. The railway line is located to the west of the growth area and has future potential to service the precinct. The area is unique and generally sits within the 8km radius from the CBD and also enjoys a close relationship to the existing Miners Rest community.

The Western Growth Area relies upon connectivity to the established road network of Ballarat West and the movement network of varying quality. Roads are typically aligned in the historical one-mile grid, however experience congestion as Ballarat has developed westward. There is opportunity to plan for active transport as part of the Ballarat West growth area and alleviate pressure from the existing roads. Access to Remembrance Drive is limited due to its role as a historical avenue of honour and western township gateway. In addition, Remembrance Drive is constrained and experiences capacity issues. The proposed Ballarat West growth area generally lies within the 8km radius from the CBD, but ultimately forms an extension to the existing Ballarat area. Planning for the growth area will require the delivery of new community and infrastructure services but the area will have a close relationship to the existing Ballarat West, including the Lucas activity centre.

Land Uses

The Northern Growth Area is largely used for farming purposes. Lots vary in size (below and above 40ha) with a number of hobby farms and rural living style lots. Future regard to the sewerage treatment plant and careful interface consideration to the northern equine precinct can be resolved as part of the PSP process. The development of the growth area will likely trigger community infrastructure. The advantages of the growth area adjacent to Miners Rest will see some synergies with existing facilities, whilst analysis will determine future infrastructure at the PSP stage.

The Western Growth Area is fragmented in parts. It is typically used for farming or rural living purposes. The area is large enough to trigger its own community infrastructure and activity centres, however there is close relationship to Alfredton and others that can be investigated.

8.8. COMPLETION REPORT: TENDER 2020/21-166 ROOF AND AIR CONDITIONING PLANT REPLACEMENT PROJECT AT NBSC

PURPOSE

1. The purpose of this document is to report to Council on contract variations that were required during the recently and successfully completed – Roof and air conditioning plant replacement project at North Ballarat Sports Club – Contract No: 2020/21-166.

2. In accordance with the Procurement Policy in place at the time of the original contract award, it is a requirement to report back to Council if variations to a contract exceed 10% of the original contract award. As variations to this project marginally exceeding 10% at approximately 10.5%, this report has therefore been prepared.

BACKGROUND

- 3. When Council purchased this building at Mars stadium it was identified that the condition of the roof was poor which caused constant maintenance issues, leaks, and disruption to Council's commercial tenant and building users. The roof was deemed beyond repair and replacement works essential to restore the asset to good repair as well as being a Lease obligation for Council to undertake.
- 4. In order to replace the roof, all air conditioning existing plant and structures on the roof were craned off. As the majority of the existing large air conditioning packaged unit plant were aged, deteriorated and at the end of standard service life, replacement and re-installation of new modern efficient air conditioning plant as well as new structural steel platform works, were also carried out as well as the new roof and other associated works.
- 5. The main complexity of the project works was in the staging and managing of the works to be undertaken safely and in a way as not to significantly impact the commercial tenant and building users operations.
- 6. It was flagged in the original Tender Evaluation Report to Council, that with the complexity of the refurbishment works to an existing aged building of this nature, that variations to the contract would be likely. Potential variations were identified for latent unforeseen conditions, unforeseen works as a result of the building's existing condition as well as potential extra operational staging management of the works to ensure minor disruption to the tenant and building user's operations.
- 7. Following a City of Ballarat tender process and contract award recommendation, on the 2 December 2020, Council resolved to: "Enter into Contract number 2020/21 166 for the provision of North Ballarat Sports Club Roof & Air-Conditioning Plant Replacement Works with SJ Weir (Ballarat) Pty Ltd for the total tendered price of \$1,226,639.00 (ex GST)".



KEY MATTERS

- 8. The works commenced in March 2021 amongst the backdrop of a challenging environment with Covid 19 lockdowns. The project successfully reached practical completion on 29 October 2021.
- 9. During the course of the project, works were required that varied the original contract award sum. These variations generally were a result of:
 - some design changes (post tender award) following input from the contractor and design team on methodology to undertake works safely, limiting disruption to tenant;
 - awarding of Mechanical Tender Options post tender award that were competitively priced during tender period;
 - existing deficiencies in the building that required rectification (not able to be identified until demolition and commencement of works).
 - minor discrepancies in design documents.
- 10. There were fourteen variations in total during the course of the project, one of which was a contract credit. This varied the final contract cost of works by \$130,209.57 & GST, approximately 10.5% above the original contract tender award.

- 11. Going into a difficult project of this nature involving replacing a roof over a busy commercial entertainment and sports venue that operates 7 days a week, there were significant risks for Council associated with completing safely without significantly impacting the tenant and building user's operations. Some of these design type variations assisted in alleviating some OH&S concerns with the works that may have resulted in shutdown of the building and the commercial tenant's operations for extended periods of time, possibly requiring Council to substantially reimburse the tenant for their loss of income potentially amounting to significant sums. No significant disruption occurred during the works and no adverse claims were made by the tenant.
- 12. The successful project outcome was also a result of a strong working relationship and communication lines between Council's Property & Facilities Management, North Ballarat Sports Club, and the contractor SJ Weirs, which has resulted in a vastly improved Council asset and strengthened relationship between Council and their commercial tenant.
- 13. It should also be noted that even with the additional costs and works required from these variations the revised contract sum remains lower than the second placed tender submission at tender award time.

PURPOSE

1. The purpose of this report is to transition the Arch of Victory/Avenue of Honour (AoV/AoH) Committee from an Advisory Committee into a Stakeholder Reference Group.

2. The purpose of this report is also for Council to endorse the updated Terms of Reference for the Arch of Victory/Avenue of Honour (AoV/AoH) Stakeholder Reference Group.

BACKGROUND

- 3. Advisory Committee's no longer exist within a legislative model following the sunsetting of this provision within the *Local Government Act 1989*. However, Council did retain the provision for Advisory Committees within its Governance Rules for utility as a community engagement mechanism, explicitly linked to strategic matters of significance aligned to the Council Plan.
- 4. Through careful consideration and constructive discussion between relevant Council Officers and the AoV/AoH Committee, it was determined that by not having a significant alignment to the Council Plan, that Council should consider the AoV/AoH Advisory Committee transitioning into a Stakeholder Reference Group.
- 5. The main function of Stakeholder Reference Groups is to provide a streamlined communication mechanism between identified stakeholders and Council Officers to ensure the views and opinions are considered within the decision-making processes of Council. Stakeholder Reference Groups are generally focused on matters more operational in nature.

KEY MATTERS

- 6. It is considered that a Stakeholder Reference Group would provide an appropriate mechanism to maintain an open and clear line of communication with nominated officers, pertaining to operational matters for AoV/AoH such as plaques and avenue tree curation.
- 7. A draft Terms of Reference was developed to reflect the transition to a Stakeholder Reference Group for AoV/AoH. The draft Terms of Reference was then distributed to the AoV/AoH Committee where following consultation a final revision was developed. Subsequently, the proposal of transitioning to a Stakeholder Reference Group and Terms of Reference was considered by the Committee at their 7 December 2021 meeting, where it was recommended to be put to Council for formal consideration and adoption.



OFFICER RECOMMENDATION

1. Background

- 1.1 By this Terms of Reference document, the Ballarat City Council (Council) establishes the Arch of Victory/Avenue of Honour Stakeholder Reference Group (SRG).
- 1.2 Council recognises the importance of stakeholder consultation in relation to the Arch of Victory/Avenue of Honour held therein. Committees to oversee the Arch of Victory and Avenue of Honour have existed since 1931 and have played an instrumental role in providing expert heritage advice, arboricultural services and advice, town planning consultation and military and historical advice. Council acknowledges the significant history of volunteer support for the Arch of Victory/Avenue of Honour, management of donations and grants, ongoing evolution of its physical attributes and promotion of its importance in the national and international context. Council also acknowledges the valued gift of the Garden of the Grieving Mother as part of the Arch of Victory precinct. Council has established this Reference Group as a means of consultation for matters relating to the Arch of Victory/Avenue of Honour.
- 1.3 Council recognise the current Arch of Victory Avenue of Honour Committee Inc as being the sole continuing community based committee for this memorial which will be a party to the SRG; and which will be consulted for the holding of any commemorative and memorial services associated with this Council memorial asset.
- 1.4 This Terms of Reference document sets out the structure and basis on which the Reference Group can function and interface with Council.
- 1.5 This Terms of Reference document is authorised by a resolution [insert resolution number after the Council meeting] of Council passed on [insert date of the Council meeting the ToR were endorsed, after the Council meeting].

2. Purpose

The Reference Group is established for the purpose of:

- 2.1 Providing a streamlined communication mechanism between identified stakeholders and Council Officers to ensure the views and opinions are considered within the decision-making processes of Council, particularly those that may involve the Arch of Victory/Avenue of Honour.
- 2.2 Provide expert advice on the Arch of Victory/Avenue of Honour on matters including heritage, arboricultural, town planning and military history.
- 2.3 Allowing joint promotion of the Arch of Victory/Avenue of Honour to ensure its national and international significance is understood, supported and appreciated.
- 2.4 Providing a consultative forum to support event planning and event activation that encourages information sharing across all user groups and stakeholders in a timely manner;
- 2.5 Enabling a consultative forum to discuss matters to improve events conducted within the Arch of Victory/Avenue of Honour precinct; and
- 2.6 Advocating for future development of the Arch of Victory/Avenue of Honour in the interests of the local community.



3. Roles and Responsibility

The role of the Reference Group is to:

- 3.1 Provide advice on the maintenance, enhancement and protection of the Arch of Victory and Avenue of Honour.
- 3.2 Promote the recognition of war time and peace time sacrifices by Ballarat service personnel.
- 3.3 Provide a consultative forum to Council, VicRoads, Heritage Victoria and other stakeholders on matters relevant to the proper custodianship of the Arch of Victory and Avenue of Honour.
- 3.4 Devise and deliver appropriate commemorative services related to the Arch and Avenue, with support from Council as outlined 3.7.
- 3.5 Reference Group members are expected to keep confidential all sensitive, commercial and personal information that the members may encounter while being a member of the Group, and not to act in any way that would bring the Council into disrepute.
- 3.6 Monitor the implementation of the Conservation Management Plan Ballarat Avenue of Honour and Arch of Victory

The role of Ballarat Council is to:

- 3.7 Undertake and fund all ongoing maintenance of the Arch of Victory/Avenue of Honour in line with the Conservation Management Plan, including mowing, gardening and tree and plaque maintenance and replacement as required.
- 3.8 Provide support and funding of commemorative events as agreed with Council which may include development of event programs and invitations, permits, traffic control and other logistical support as agreed on a case-by-case basis.
- 3.9 Apply for all applicable planning, grant funding and heritage permits as required.
- 3.10 Provide an ongoing operational contact to Reference Group members to assist in repairs, maintenance and other urgent matters.
- 3.11 Provide administrative support for the purposes of Reference Group meetings.
- 3.12 Provide Public Liability and Professional Indemnity Insurance for members of the Stakeholder Reference Group while acting in the capacity as a Stakeholder Reference Group member.

4. Membership

- 4.1 The Arch of Victory/Avenue of Honour Stakeholder Reference Group will consist of a minimum of 8 members comprising of the following:
 - Up to two Councillors
 - One representative of the Ballarat RSL
 - One representative of VicRoads / Regional Roads Victoria
 - Council Arboriculture Officer or other Council operational officer
 - Two representatives of the Lucas Past Employees Association
 - One representative of the National Trust of Australia Ballarat Branch

- Six representatives from the AoV/AoH Committee Incorporated Association; and
- A maximum of six additional community representatives including service clubs, or any additional community members not described above.
- 4.2 The Chief Executive Officer shall appoint a Council Officer to provide administrative support and guidance to the Reference Group.
- 4.3 A Council Officer appointed under clause 4.2 is not considered a member of the Reference Group.
- 4.4 A Chairperson will be elected at the first meeting of the Reference Group.
- 4.5 If the Chairperson is absent from a Reference Group meeting, the Reference Group will select a temporary Chairperson to chair the meeting.
- 4.6 Any Councillor can attend the meeting as a non-voting observer.

5. Meetings

- 5.1 Unless Council resolves otherwise, Reference Group meetings will be conducted at the Group's discretion under the direction of the Chairperson.
- 5.2 The Reference Group shall meet at least on a twice-yearly basis and at such times and places as are necessary to enable it to exercise and discharge its functions as described herein.
- 5.3 The Chairperson will chair all Reference Group meetings.
- 5.4 The Chairperson is the authorised spokesperson for the Group.
- 5.5 The role of the Council Officer appointed under clause 4.2 includes:
 - maintaining a Register of Reference Group members, their date of appointment, reappointment and official positions (if any) held as a Reference Group member;
 - advising Reference Group members of term completion dates and their eligibility for reappointment as relevant;
 - acting as the contact point between Council and the Reference Group; and
 - assisting with meeting the Reference Group's reporting requirements.
- 5.6 A quorum of the Reference Group will be half of the members plus one.

6. Decision-Making Process

6.1 The Reference Group is a consultative forum and hence consensus or other decision-making processes are not required.



7. Reporting

- 7.1 The Reference Group is responsible for taking proper minutes of all meetings.
- 7.2 The Reference Group shall provide Council with a summary report of its activities upon being requested to do so by Council.

8. Creation and Dissolution

- 8.1 These Terms of Reference:
 - 8.1.1. come into force immediately the resolution of Council adopting them is made; and
 - 8.1.2. remain in force until Council determines to vary or revoke them.
- 8.2 By these Terms of Reference, the Reference Group:
 - 8.2.1. is established; and
 - 8.2.2. has the responsibilities as set out in this Terms of Reference document.
- 8.3 The Reference Group can be dissolved by resolution of Council.
- 8.4 The Terms of Reference will be reviewed as required.

PURPOSE

1. To review and update the S6 Instrument of Delegation, Members of Staff for Council's consideration.

BACKGROUND

- It is proposed that the Instrument of Delegation be granted to the positions of members
 of Council staff rather than to the individual staff member. This means that the
 delegation will still apply to the position should there be a change in personnel or any
 staff acting in the role.
- 3. It is imperative that Council staff have the correct delegation for dealing with matters under the current Acts and Regulations.
- 4. The powers conferred on the Council under some legislative Instruments cannot be delegated through the Chief Executive Officer and must be delegated from Council.

 - Legislative changes to the provisions of the Cemeteries and Crematoria Act 2003, Food Act 1984, Planning and Environment Act 1987, Road Management Act 2004; and

OFFICER RECOMMENDATION

- 6. Exercise the powers conferred by the legislation referred to in the attached instrument of delegation at Attachment 2, and that:
 - 6.1. There be delegated to members of Council staff, holding, acting in or performing the duties of the officers or positions referred to in the attached Instrument of Delegation to members of Council staff, the powers, duties and functions set out in that instrument, subject to the conditions and limitations specified in that instrument.
 - 6.2. The Instrument comes into force immediately after the Common Seal of Council is affixed to the instrument.

Thank you for your questions.

 Could Council please advise how the newly constructed dwelling at 20 Catalina Court, Ballarat East (and surrounding dwellings) comply with the requirement all new dwellings must have a floor level 300mm above the 1% AEP flood event and satisfies the other requirements.

The subject site forms a 2011 VCAT Order approving a Planning Permit for a staged subdivision of 40 lots. I'm satisfied as part of this process that the required drainage/stormwater infrastructure was provided by the land developer in accordance with the planning permit conditions. This application was referred to the relevant CMA who did not object to the development and did not attend VCAT as a party to the matter.

The land is zoned General Residential and is not subject to any overlays, including a Flood overlay. Therefore, no planning permit is required to develop a single dwelling.

As part of the building permit process a Property Information Request would be made by a landowner or builder for each site. All property information reports include the following question:

Is the land located in a designated flood area in accordance with Regulation 802?

In this instance the response has been:

No. The property has not been designated as "liable to flooding" within the meaning of regulation 802 of Building Regulations 2006. However, City of Ballarat strongly recommends seeking further flood advice from the relevant Catchment Management Authority with regard to any recommendation for appropriate location and floor level of any building works on this site

The onus falls on the owner, the builder and the building surveyor. It is not illegal to build below any floor level, but it also means that the owner must accept the risk of potential flooding in a 1 in 100-year AEP (annual Exceedance Probability) flood event.

The flood study produced for the area indicates that development will help reduce the potential for flooding in Catalina Court. Works in the development and surrounds will likely reprofile some parts of the existing surface and channel flows more directly into the drainage system.

 Despite modelling that suggests no new dwellings will flood, what action is Council taking to prevent flood damage when we next have a flood event similar to, or worse than, the 1990s.

You have acknowledged that the modelling suggests that new dwellings are not likely to be subject to flood. If an exceptional event occurs and the owner has not through their own due diligence, that the onus falls on the private Building Surveyor who has approved the final Building Permit which would show floor levels.

I will add that the Flood Overlay amendment is anticipated to go on exhibition in 2022, although this amendment would not be retrospective and only applicable to new development.

Thank you for your questions submitted to Council, at its meeting held last night, 15 December, 2021 and I am pleased to provide you the following response:-

Question 1

Council provides a variety of services for which there is a direct fee as per Councils adopted fees and charges in the annual budget - for example fees to use the facilities at the Ballarat Aquatic and Leisure Centre. In the particular instance of a direct fee being charged for this type of service, Council has provided the opportunity for a reduced fee or no fee during the period of COVID restrictions and also has given customers an opportunity to put their membership fees on hold once the Ballarat Aquatic and Leisure Centre was able to be reopened.

For a general charge, such as the annual rates charge, which covers a wide range of services, which are provided to the community without there needing to be any direct correlation to the service used and the amount charged, Council currently has no intention that I am aware of to provide any reimbursements to ratepayers for the general rate charge. Council has recently adopted a financial hardship policy which provides guidance for ratepayers whom may be experiencing difficulty paying their rates.

Question 2

Council's facilities continue to responsibly manage access to the public in a COVID safe way in line with the open premises and stay safe directions of Victoria's Chief Health Officer. These directions provide the basis upon which Council's COVIDSafe plan has been prepared and implemented to provide a safe environment for the public to have these facilities open.

Council will continue to assess and follow the directions of the Chief Health Officer.

Extracts from Governance Rules

3.8.1 Councillors may propose Notices of Motion

Councillors may propose an issue to be listed on the agenda by lodging a Notice of Motion in accordance with the rules outlined in this Chapter.

3.8.2 Notices of Motion

- Prior to a Council meeting, Councillors wanting to include a matter on the agenda, must complete a notice of motion form.
- b) A notice of motion form must be signed by the Councillor; and be lodged with the Chief Executive Officer (whether personally, email or otherwise) by 4pm the Thursday before the Council meeting agenda is due to be published. So as to allow sufficient time for him or her to give each other Councillor notice of such notice of motion; and to allow sufficient time for the notice of motion to be put in the agenda for the next Council meeting. If a notice of motion form is received after that time, it must, unless withdrawn, be included in the agenda for the following Council meeting
- c) The Chief Executive Officer must reject any notice of motion which:
 - is too vaque;
 - ii) is identical or substantially similar to a notice of motion or a rescission motion that has been considered by the Council and lost in the preceding six (6) months;
 - iii) is defamatory;
 - iv) may be prejudicial to any person or Council;
 - v) is objectionable in language or nature;
 - vi) is outside the powers of Council;
 - vii) is a notice of motion submitted during the Caretaker Period; or
 - viii) is a matter subject to a Council decision making process which has commenced but is not yet complete.
- d) If the Chief Executive Officer rejects a notice of motion under sub-rule 3.8.2 c), he or she will inform the Councillor who lodged the notice of motion of that rejection and the reasons for it. The Councillor will be provided with 24 hours to lodge a revised notice of motion provided that the meeting at which the notice of motion is to be considered is more than 24 hours from the time of rejection.
- e) The Chief Executive Officer may reject and refer any notice of motion to the Council's operational service request process if it relates to a matter that he or she determines is more appropriately addressed that way.
- f) Subject to sub- rules 3.8.2 g) and h) a notice of motion must call for a Council report if the notice of motion:
 - substantially affects the level of Council services;
 - ii) commits the Council to expenditure in excess of \$20,000 and that has not been included in the adopted budget;
 - iii) establishes or amends a Council policy; or
 - iv) commits the Council to any contractual arrangement,
 - as determined by the Chief Executive Officer.

- g) Where a notice of motion is likely to commit Council to significant expenditure not included in the adopted budget then the notice of motion must call for a report for Council's consideration and public submission process if applicable.
- h) The Chief Executive Officer may direct a notice of motion to be confidential in accordance with Section 66(2)(a) of the Act, in which case the notice of motion will be confidential unless the Council resolves otherwise.
- The full text of any notice of motion accepted by the Chief Executive Officer must be included in the material accompanying the agenda.
- j) The Chief Executive Officer must arrange for a formal report to be prepared and presented to the Council for the purposes of sub-rule f). Where practicable the report should be presented to the next Council meeting.
- k) The Chief Executive Officer must cause all notices of motion to be numbered, dated and entered in the notice of motion register in the order in which they were received.
- Except by leave of Council, each notice of motion must be considered in the order in which they were received by the Chief Executive Officer.
- m) If a Councillor who has given a notice of motion is absent from the Council meeting or fails to move the motion when called upon by the Chairperson, any other Councillor may move the motion.
- If a Councillor proposing the motion wishes to amend the notice of motion, he or she
 may do so by seeking leave of the Council to amend the notice of motion prior to it
 being seconded.
- o) The Chairperson, having lodged a notice of motion in accordance with this sub-rule, must vacate the Chair of the Council meeting to move the notice of motion; and the Deputy Mayor or, in the absence of the Deputy Mayor, temporary Chairperson appointed by the Council, will take the Chair for the duration of consideration of the item.
- p) If a notice of motion is not moved at the Council Meeting at which it is listed, it lapses.
