RE: PERMIT P35384 - HER MAJESTY'S THEATRE, 17 LYDIARD STREET SOUTH BALLARAT CENTRAL, BALLARAT CITY (H0648)

Thank you for your letter dated 20 December 2022 providing information requested under condition 2, 3, 4, and 5 of permit P35384 which allows for Stage 3 works associated with accessibility, safety & compliance, and functionality upgrades throughout Her Majesty's Theatre, Ballarat.

Condition 2 requires:

The Executive Director, Heritage Victoria is to be given five working days' notice of the intention to commence the approved works.

The information you have provided satisfies the condition.

Condition 3 requires:

Prior to the commencement of any of the works approved by this permit, a Heritage Management Plan (the Plan) must be provided for endorsement by the Executive Director, Heritage Victoria and once endorsed becomes part of the permit. The Plan must include a sequencing program for the approved works, details of any temporary infrastructure and services required, protection methods for the heritage place during the undertaking of the works, and a work site layout plan.

You have provided the following in relation to these conditions:

 Heritage Management Plan prepared by Nicholson Construction dated 10 May 2022 (sections 1 - 3.5 and appendixes 7, 8, and 9)

The information you have provided satisfies the condition.

Condition 4 requires:

Prior to the commencement of any of the works approved by this permit, a final plan addressing the storage methodology and location of the auditorium chairs to be removed and stored is to be provided for endorsement by the Executive Director Heritage Victoria and once endorsed becomes part of the permit.

You have provided the following in relation to these conditions:
